# **CALL TO ORDER:**

Chair Ogelman called the meeting to order at 7:00 PM and Vice Chair Neham led the Pledge of Allegiance. Vice Chair Neham reviewed the Speaking Guide.

# **CITIZEN COMMENTS (first opportunity):**

Chair Ogelman read citizen emailed comments from Cheri Stark and Philip Ulanowsky into the record.

# **APPROVAL OF MINUTES:**

# a. April 1, 2021 Regular Meeting

Commissioner Forbes made a motion that the Planning Commission approve the minutes from the April 1, 2021 meeting and waive reading. The motion was seconded by Commissioner Kowalski and carried 7-0.

# **ACTION ITEM(S):**

# a. C-4 Zoning District Text Amendments (ZTA21-01, ZTA21-03, ZTA21-04)

Vice Chair Neham made a motion that the Planning Commission recommend approval of Ordinance 21-02-01; C-4 Zoning text amendments ZTA21-01, ZTA21-03, and ZTA21-04. The motion was seconded by Commissioner Forbes and a discussion commenced.

Commissioner Paciulli asked if staff's comments and adjustments would be discussed. Vice Chair Neham confirmed that the Planning Commissioners comments were addressed by staff to the Commissioner's satisfaction. Commissioner Paciulli raised concern for Issue 2: To avoid getting administrative difficulties caused by attics, basements, and spaces under gable roofs. It was determined that this would be addressed as a matter of definitions and be made clear in a future meeting. After a detailed discussion on this topic, Commissioner Paciulli withdrew his suggestion on this issue. No amendment was made.

The motion carried 7-0. Chair Ogelman confirmed that this would be forwarded to Town Council.

# a. Adjudication of RFP Statement of Work Comments/Recommendations

Vice Chair Neham will be sending out an updated spreadsheet to Commissioners after compiling received comments, proofreading, and then planning to move forward. Chair Ogelman confirmed with Town Attorney that this would not constitute a meeting when only Vice Chair receives comments.

Town Attorney referenced a section to reword in the SOW RFP and would make requested amendments and send to Vice Chair Neham by email.

#### b. Project Plan Review

Chair Ogelman will send out an updated Project Plan Review for review by the Commissioners; would not constitute a meeting. This Project Plan will be shared with Town Council.

# c. Review of O&A

Chair Ogelman conducted a straw vote to table this item and Commissioners agreed.

# d. Review and Revision of Historic Overlay Zone Ordinance; Public Hearing Plan

Chair Ogelman suggested a straw vote to table this item and Vice Chair Neham requested to Town Attorney gave a short summary. Town Attorney shared the Public Hearing Plan was discussed at the last meeting and it was prioritized with other contracts and would be 6 weeks out that still stands. Director of Planning and Economic Development confirmed the Planning Commissioners consensus that if any parcel associated with a particular address has a historic resource on it, then all of the parcels associated with that particular address will be colored the same on the map.
