- 2. The screen wall on the rear elevation shall be reduced to most efficient profile to minimize the visual impact.
- 3. Lighting: Exterior lighting is to be wall mounted, located as shown on the site plan, and of the type shown in the submitted cut sheets.
- 4. Dumpster Enclosure: The dumpster enclosure should be made of concrete block, of a color and texture and to coordinate with the building.

5. The smooth concrete block shall be ground face.
