Robert Schonder, 701 W. Main Street spoke about his disappointment with no citizen engagement for the renaming of Harry Byrd Highway.

Andrea Broshkevitch, 17177 Pickwick Drive spoke about the need for the change in traffic pattern at Berlin Turnpike and Eastgate Drive.

Casey Chapman, 205 Hirst Road, spoke about the article in the Blue Ridge Leader, the intersection of Eastgate and 287, disapproval of comments made by Council to further decrease the budget, and the value of the police department.

Brian Dean, 601 W. Main Street (remote participation), spoke in disappointment of not having citizen participation for the renaming of Harry Byrd Highway.

MAYOR AND COUNCIL COMMENTS

b. Bike Park Update

Council member Stinnette made a motion that Town Council authorize the Town Manager to enter into contracts with American Ramp Companies, Inc. and all other contracts needed to develop the bike park. **(Carried: 7-0, Grewe: Aye, Bertaut: Aye, Stinnette: Aye, Williams: Aye, Milan: Aye, Rayner: Aye, Fraser: Aye)**

Council member Stinnette made a motion that Town Council direct the Town Manager and staff to incorporate the initiative into the Town's Capital Improvement Program. **(Carried: 7-0, Grewe: Aye, Bertaut: Aye, Stinnette: Aye, Williams: Aye, Milan: Aye, Rayner: Aye, Fraser: Aye)**

Council member Stinnette made a motion that Town Council direct the Town Manager and staff to secure \$63,500 of ARPA funds in support of the bike park. **(Carried: 7-0, Grewe: Aye, Bertaut: Aye, Stinnette: Aye, Williams: Aye, Milan: Aye, Rayner: Aye, Fraser: Aye)**

Council member Stinnette made a motion that Town Council accept Michelle Caudill's cash donation to be used exclusively for the development of the Adam Caudill Bike Park which donations may be made in one or more parts.

c. Software as a Service Agreement – Glass Commerce

Glass Commerce was presented to the Economic Development Committee (EDAC) however no metrics have yet to be defined. The item has been put on hold until EDAC has a report prepared for the Town Council.

d. POLCO Agreement Renewal

Council member Grewe made a motion the Town not renew the POLCO agreement for the upcoming year.

CLOSED MEETING

Council member Milan requested an item be added to receive an update on the open-mic issue that remains open.

Council member Stinnette made a motion, as authorized under Section § 2.2-3711(A)(29) of the Code of Virginia, that the Town Council convene in a closed meeting to discuss the terms of a public contract, because discussion in an open session would adversely affect the bargaining position or negotiating strategy of the public body. Specifically, the Council will discuss the proposed agreement between the Town and Loudoun County for the construction of a cell tower on the Fields Farm Park property.

Further, as authorized under the Code of Virginia Sections § 2.2-3711(A)(1) and (A)(8), the Town Council convene a closed meeting to discuss the performance and possible discipline of two appointees of the Town Council, and to receive legal counsel from the Town Attorney regarding the same.

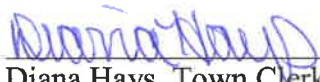
