CALL TO ORDER:

Mayor Fraser called the meeting to order at 7:00 PM. The Pledge of Allegiance followed.

AGENDA AMENDMENTS:

Mayor Fraser added Mayor/Council Comments to work session agendas starting this evening. Council member Rayner added 10c.Update on Google. Council member Stinnette requested to move 9c. Appropriation for Leased Police Department Facility Renovations and Acceptance of Bid to become 9a. Town Council's Direction on Expiring Planning Commissioners Terms/Vacancy. Sally Hankins, Town Attorney, added a Closed Session on Fields Farm Park legal advice.

a. Donation from United Bank to Adam's Bike Park

Kurt Marx, Market President/EVP, United Bank and Marie Brooks, Senior Branch Manager of Purcellville, presented a check to Michelle Caudill for \$15,000 for Adam's Bike Park. Adam's Bike Park is scheduled to open October 22nd.

b. Aer Wireless Broadband Solution to the Home and Business for Purcellville

Keith Walker, Founder/CRO & CTO gave the presentation.

CITIZEN COMMENTS:

Harry Lloyd Harting, 845 Pencoast Drive Mayfair HOA, referred to the planned Mayfair Crown Drive survey being created. He suggested two other options: 1.Leave as is with no connection to either road and 2. Permit residents to submit other options.

Bill Conover, 811 West Country Club Drive, shared comments on why the rush for the Fields Farm Project and to slow down the process.

Christine Green, 229 Upper Heyford Place, shared comments on her submission of a petition that she gathered from 133 Mayfair residents regarding Mayfair Crown Drive with 87% of polled in favour of it not becoming a connector road and commented to listen to the Planning Commission meeting last week. She suggested working along with the County with the Fields Farm Project.

Casey Chapman, Business owner 205 Hirst Road CASECO LLC, 34928 Snickersville Turnpike Round Hill, shared to keep working with the County and the residents of western Loudoun to keep some of those tax dollars on the Field Farm project to be located somewhere in the town or surrounding area. He shared comment on the Vineyard Square Project and it not being related to the O Street project and requested and update traffic study be done.

Bill Conover, 811 West Country Club Drive, sent an email to be read into the record by Diana Hays, Town Clerk, regarding unsatisfactory service done by American Disposal.

MAYOR/COUNCIL COMMENTS:

Council was given 5 minutes.

a. Appropriation for Leased Police Department Facility Renovations and Acceptance of Bid

Chief Cynthia McAlister gave the report.

2. Use ARPA for Public Safety Payroll and Use Associated Operating Budget Savings to Fund Renovation:

Council member Grewe moved the Town Council approve BA23-004 Option #2 to appropriate \$ 1.4 million from the American Rescue Plan Act (ARPA) Public Sector Revenue Loss allocation for FY 2023 Public Safety Payroll and use the associated FY 2023 General Fund operating savings to fund the Police Facility Renovation. Additionally, Council member Grewe moved the Town Council approve BA23-004 Option #2 to defund \$800,000 of the ARPA allocation to complete the Police Facility Renovation project and amend the Town's ARPA spending plan accordingly.

Council member Grewe moved that Town Council adopt the proposed Mayfair Crown Drive Survey (attached) relative to the Fields Farm amenities, the text as written and presented on the screen per the direction given to staff that would be handed out to all the properties in the Mayfair HOA. Friendly amendment by Vice Mayor Bertaut to read "Mayfair subdivision" and staff added "residential subdivision".

ADOPTED: SEPTEMBER 27, 2022

AN ORDINANCE: EXTENDING THE PLANNING COMMISSION'S DECISION

DEADLINE ON COMMISSION PERMITS 20-01 AND 20-02 ASSOCIATED WITH THE FIELDS FARM PARK PROPOSAL

WHEREAS: The County received two Commission Permit applications from Loudoun

County on June 30, 2021: one for a group of athletic fields, and the other for a commuter parking lot, both associated with a project known as Fields

Farrh Park: and

WHEREAS: A Commission Permit is a review of any proposed public park, public

structure, or other public area that is not already shown on the adopted Comprehensive Plan. The purpose of the review is to determine whether the proposed public facility is in "substantial accord" with the adopted

Comprehensive Plan.

WHEREAS: Virginia Code grants decision-making authority for Commission Permits to

the Planning Commission. The Planning Commission's decision is final

unless appealed to the Town Council.

WHEREAS: In making its decision, the Planning Commission is charged with

determining whether the general location, character, and extent of the proposed public facility is "substantially in accord" with the adopted

comprehensive plan or part thereof.

AN ORDINANCE: EXTENDING THE PLANNING COMMISSION'S DECISION DEADLINE ON COMMISSION PERMITS 20-01

AND 20-02 ASSOCIATED WITH the FIELDS FARM PARK PROPOSAL

WHEREAS:

Virginia Code Section 15.2-2232 requires that the Planning Commission act upon a Commission Permit within 60 days from its submission to the Town. Failure of the commission to act within 60 days of a submission shall be deemed approval, unless the time is extended by the governing body.

WHEREAS:

The 60-day deadline expired on August 30, 2021.

NOW THEREFORE: The Town Council of the Town of Purcellville, Virginia hereby ordains:

Section 1. That the deadline for the Planning Commission to act upon the aforementioned Commission Permit applications is extended from August 30, 2021, to February 1, 2023.

That this Ordinance shall be retroactively effective as of August 15, 2021.
